BACKGROUND INFORMATION: On a recent motor vehicle crash requiring extrication, our rescue truck was unable to make the scene for various reasons. The vehicle has to sit outside due to lack of interior bay space. As a result, the fluids are cold, making it more difficult for the underpowered motor to move the vehicle. Most of our driver training occurs in the summer time, and this was the first wintertime extrication we have been called to, so we were not aware of the problem with the underpowered motor in the cold weather.

Other options were researched and this is the most cost effective measure that allows us to keep the existing truck and equipment. The cheapest vehicle we found was \$23,000 and it was a much smaller vehicle, which would require us to remove needed rescue equipment.

The TSV FD Fire Board discussed the issue and decided this was the best option.

RECOMMENDATION: To approve the allocation of funds to replace the gasoline engine with a Cummins diesel engine that has both the low-end torque and horsepower to get the vehicle to any scene as needed.
