BACKGROUND INFORMATION:

The Village of Taos Ski Valley's Planning and Zoning Department and Public Works Department have been working together to form a more consolidated and streamlined method of snow removal and have been doing so by working to identify the weaknesses of the existing language in Ordinance 2013-30. This new language concerning snow removal will work not only to combine the various snow removal and snow storage responsibilities within Ordinance 2013-30, it will form a cohesive plan, working to integrate all stakeholders involved in the snow removal operations within the Village. Stakeholders include VTSV's Public Works Department, Businesses, Residents, and Private Contractors. All language would be consolidated under Section 7.4 General Provisions/Snow Safety

Staff has worked to create language within the Ordinance to reference a document that shall serve as a Contractor/Village plowing agreement. Prior to commencing any private or public snow removal work requiring the use of public roads and public rights-of-way, contractors will be required to notify Village Staff in order to locate infrastructure and utilities that might be buried or are not visible due to weather conditions. Additionally, all contractors will be required to sign the Contractors Snow Plowing Agreement indicating who they intend to have working their equipment, how and where they access public right of ways and roadways, and where they intend to deposit the relocated snow.

During the revision of the Zoning Ordinance that took place preceding the 2010 version, language was added referencing the use of a hearing officer for hearing evidence. Since the Commission is hearing evidence at public hearings, not a hearing officer, it would be best to change this language.

The Snow Removal language has been brought to and reviewed by the Planning and Zoning Commission multiple times. This final will be reviewed at the November 4, 2013 meeting. The changes to the language referencing the use of a Hearing Officer were unanimously approved at the Planning & Zoning Commission August 5, 2013 meeting.
