The purpose of the ordinance, in part, is to reduce the potential for wildfire that can occur when overhead service lines come into contact with trees by mandating the elimination of overhead electrical service and requiring the conversion to underground service for all properties and structures within the municipal boundaries of the Village.

BACKGROUND INFORMATION:

At the end of each fiscal year it is necessary to adjust the budget. Some funds (departments) may have gone over their budget while others have gone under but the total budget remains under budget. These adjustments are necessary in order to balance the budget.

Water and Sewer Operating:

6320: Legal fees have increased significantly over the fiscal year mainly due to the LCI2 vs. VTSV lawsuit. The good news is that the litigation has been settled, bad news...we still had a few bills outstanding to Stelzner, Winter, Warburton, et al.

4012 REVENUE – WATER/SEWER 6320 LEGAL SERVICES Increase by \$18,500.00 Increase by \$18,500.00

Water Depreciation Reserve:

4027: Settlement/mediation agreement LCI2 vs. Village of Taos Ski Valley was not budgeted. 6220: The Chlorination Station required a culvert not included in the budget. We experienced some issues at the Chlorination Station that required hiring Glorieta Geoscience to analyze the low flow. 8322: Engineering costs far exceed expected budgeted amount for water projects this fiscal year.
