5. CITIZENS FORUM

Introduction of Peter Talty, Representing Louis Bacon

Mr. Talty introduced himself representing Louis Bacon, the new TSV, Inc. owner. He spoke about plans for the corporation including the Village base/core area. Plans will be presented to the P&Z Commission in the near future.

Kerrie Pattison, Northside at Taos Ski Valley В.

> Kerrie Pattison spoke about her concerns with the cell and internet problems in the Village over the holidays including the unhappy guests and possible safety issues. Administrator Fratrick had registered a complaint with Verizon and supplied

several cell numbers that were experiencing difficulty texting and receiving calls. Councilor Stagg explained that it is not the fault of the carrier (Verizon) as there is not sufficient bandwidth between the Village and the Town of Taos. This should be solved when the fiber optic line is installed by Kit Carson Electric and that schedule is unknown. Stagg said this is a priority of the new owners. Discussion was held. Bill Sullivan said he will try to get a refund and he urges everyone else to do the same.

6. FINANCIAL REPORTS

Monthly Financial Reports

Clerk/Treasurer Chisholm reported that the GRT is down by about \$37,500. Construction is still the major contributor to the GRT. Next month a mid-year review and the Profit and Loss comparison will be distributed. The budget process will begin in February.

7. COMMITTEE REPORTS

A. Planning and Zoning Commission

Councilor Wittman reported the P&Z Commission met on January 6, 2014. Snow storage was discussed and the Village may need to purchase land in the future, possibly on O.E. Pattison Loop and in Amizette. The Village lease agreement with the Pattison Trust would allow snow storage on the Phoenix Switchback, which is preferable to trucking up Kachina Road. A master plan for the Village core area was presented by Peter Talty. The next meeting is scheduled for Monday, February 3, 2014, at 1:00 p.m., at the Edelweiss Lodge and Spa Club Room.

B. Public Safety Committee

Councilor Bennett reported the committee did not meet. There will be a meeting in January to discuss the appointment of a Firewise Community Board of Directors. This is a requirement for the Village becoming a firewise community.

C. Parks and Recreation Committee

No meeting. The next meeting is scheduled for January 14, 2014, 3:30 p.m. at the Edelweiss Lodge and Spa Club room.

D. Lodgers' Tax Advisory Board

8. REGIONAL AND STATE REPORTS

Mayor Pro Tem Wiard asked Administrator Fratrick to report on the Taos Regional Landfill Board Meeting. Wiard reported on the Intergovernmental Council (IGC) of the Enchanted Circle meeting including regional priorities and plans for Enchanted Circle Day at the Legislature (January 22). The 30 day 2014 Legislative Session will be from noon January 21 to noon on February 20, 2014. The NM Municipal League priority is again to protect and maintain municipal revenues, focusing on alternatives for the phase out of the GRT hold harmless provision. Municipal Day at the Legislature will be on February 7, 2014. Additional future meetings include the North Central NM Economic Development District in Santa Fe.

9. MAYOR'S REPORT

Mayor King attended a Forest Service planning meeting. King discussed EQR's and budgeting for water and sewer, the slash pile and burn permits. He discussed the possibility of televising the Council meetings. At this point the capacity of the internet's bandwidth questions the viability.

10. STAFF REPORTS

Administrator Fratrick gave an update on several topics. He has contacted the environmental organization, SE Group, for the next steps needed for the Townsite Act. All parties have signed the transportation contract, maintenance is complete, and the van is ready to go, as per the Community Navigation Tiger Team (CNTT) van plan. The Chile Line MOU with the Town of Taos was signed and executed. The RFP for a general engineering firm will be advertised on Thursday, January 9, 2014. During the holidays several people were scammed using craigslist ads, renting locations in the Village that do not exist. The Village has posted an ad on craigslist advising users to verify with the Village Chamber of Commerce. The Village 2014 Capital Expenditure Appropriation Request has been submitted. This reflects the Village ICIP priority one, Village Waste Water Treatment Plant Improvements. Phase I (\$500,000) is the purchase or acquisition of the land from the Forest Service through the Townsite Act. Phase II (\$4,000,000) is to plan, design, and upgrade the Wastewater Treatment Plant. The total cost for the project is \$4,500,000. \$500,000.00 has been requested to begin Phase I.

Director Wallace reported on activity during the holidays. These included car accidents, a carbon monoxide call to a home with detectors, an elevator rescue in the Edelweiss, and fire alarms that turned out to be false. Follow up with the Attorney General's office regarding the craigslist scam has been done. Kathleen Sullivan was given appreciation for finding the scam victims a place to stay over the holidays.

Director Keen reported that the cold weather is affecting the wastewater treatment plant. Extreme drops in water temperature across the aeration basins caused the plant to lose its nitrification process resulting in the purchase of more nitrifiers (i.e. bugs) to replace the ones that died. We have no control over the wastewater temperatures coming into the WWTP. This remains a problem. Staff was treating 95,000 gallons over the holidays. Keen also reported that there were compactor problems; not enough pulls scheduled over the holidays.
