The special meeting of the Village of Taos Ski Valley Council was called to order by Mayor King at 2:00 p.m. The notice of the meeting was properly posted.

3. APPROVAL OF THE AGENDA

4. DISCUSSION, CONSIDERATION, AND POSSIBLE ACTION TO APPROVE AN ADJUSTMENT TO THE WATER AND SEWER RATES THAT WERE PREVIOUSLY APPROVED AT THE JULY 2, 2013, REGULAR COUNCIL MEETING

The calculation of the rates presented at the July 2, 2013 Council meeting was based on water/sewer usage from a few years ago. When last year's usage was entered into the spreadsheet, there was a projected shortfall in revenue due to decreased water usage. The target amount needed to run the water and wastewater operations, plus fund a reserve account, would not have been attained with the approved rates. The Council decided that the options were to increase the fixed rate, increase the usage rate, increase both, or leave the rates as approved. After much discussion it was decided to increase the usage rate for water and sewer usage from \$0.0320 per gallon to \$0.0400 per gallon. The projected revenue would be derived from 49% fixed charges and 51% usage charges.

MOTION: To approve an adjustment to the water and sewer rates by increasing the usage rate to \$.040 per gallon. Rates will be re-evaluated at the beginning of each new fiscal year, based on usage from the previous calendar year.
