3. DUST WORKSHOP

Mark Fratrick, Village Administrator, presented a Power Point presentation to the Village Council and the citizens of Taos Ski Valley.

After the presentation the dust issues were addressed in an open discussion. Items discussed included magnesium chloride applications on the road, buying a used water truck and the problem with speeders.

Village staff had five items to consider for addressing the dust problems in the future: 1) applying a chip seal to the road; 2) grading and maintaining the roads; 3) applying magnesium chloride; 4) purchasing a used water truck for spraying the roads; 5) enforcing the speed limit and using speed limit signs.

In addition, a discussion included purchasing cameras to take pictures and automatically send out tickets to the speeders.
