Last day to request Absentee Ballot Application. - VTSV Office, Friday, February 28, 2014, 5:00 p.m.

Election Day - Voting takes place at the Edelweiss Lodge and Spa Club Room, Tuesday, March 4, 2014, 7:00 a.m. - 7:00 p.m.

Election Results - Talled at Edelweiss Lodge and Spa Club Room posted outside the door and also at the VTSV Office.

Election judge proclaims and posts unofficial results of total votes cast for each candidate. Time will be determined by length of time it takes precinct board to tally ballots.

Canvass of Election - VTSV Office
By noon on Friday, March 5, 2014.

Certificate of Election prepared by Village Clerk for each elected candidate. Must be done by Monday, March 10, 2014 at 5:00 p.m. at the VTSV Office.

Oath of Office - Each elected candidate shall personally appear to sign a written statement acknowledging receipt of the certificate and that she or he is legally qualified to hold office. After canvass and preparation of the certificates of elections and not later than 7:00 p.m. on Monday, March 10, 2014.

Village Council Meeting - Between Monday, March 10, 2014 and Tuesday, March 25, 2014 the governing body must hold an organizational meeting. This may be a regular or special meeting.

Candidacy Filing Date

Declarations of Candidacy shall be filed with the Village of Taos Ski Valley (VTSV) Clerk on Tuesday, January 7, 2014 between the hours of 8:00 a.m. and 5:00 p.m. at the Village Clerk's office, 7 Firehouse Road, Taos Ski Valley, New Mexico.

The following documents are required by law for certification as a candidate:

1. A Declaration of Candidacy (form provided in this packet)
Please note: the name and resident street address (not Post Office Box) on the Declaration of Candidacy form must match the affidavit name and resident street address of voter registration described in next section.
2. A certified copy of the candidate's current affidavit of voter registration on file with the County Clerk which has been certified by that office on a date no earlier than December 3, 2013. The candidate must go to the County Clerk's office to pick up an affidavit. The County Clerk's office is located at 105 Albright Street, Suite D, Taos, 737-6380.

If you cannot appear in person on January 7, 2014 to declare candidacy, you may fill out an Affidavit Authorizing Filing of Declaration of Candidacy (form provided in this packet), which assigns a person to declare your candidacy.

Please note that there are three Notaries Public in the Village of Taos Ski Valley (VTSV) office if you need their services.

Candidates Drawing for ballot position

At 5:01 p.m. on Thursday, January 9, 2014 the VTSV Clerk, in the presence of the certified candidates (or authorized representatives) who desire to be present, administers an impartial and fair drawing by lot to determine the order the candidates' names will appear on the ballot. The VTSV Clerk draws for any candidate or his/her representative who is not present.

If you cannot appear in person for the drawing of the order of candidates and you want someone to attend for you, you may fill out an Affidavit Authorizing Filing of Declaration of Candidacy (form provided in this packet), which assigns a person to represent you at the drawing.

Withdraw Candidacy

Any candidate for municipal office may withdraw his/her candidacy by filing an affidavit in the Village Clerk's office, 7 Firehouse Road, on a form included in this packet. The Village Clerk shall not place on the ballot the name of any person who has filed such an affidavit by Tuesday, January 14, 2014, 5:00 p.m.

Please note that there are three Notaries Public in the Village office if you need their services.

Precinct Workers and Translators

Village Council to vote on Precinct Workers and Translators at Village Council Meeting, Tuesday, January 7, 2014, 2:00 p.m.

March 4, 2014 - ELECTION DAY: Precinct workers will be required to arrive at the Edelweiss Lodge and Spa by 6:50 a.m. and stay until the election results are tallied (approximately 7:30 p.m.).

Each precinct worker will be compensated for their services at a rate of \$100.00 for election day and will be paid no later than thirty days after the election.

Please note: NMSA 1-2-7

Precinct Board; qualification of members.

- A. In order to qualify as a member of the precinct board, a person shall:
- (1) be a resident of the representative district and county in which the precinct where she/he is a voter is located;
 - (2) be able to read and write;
 - (3) have the necessary capacity to carry out his functions with acceptable skill and dispatch; and
 - (4) execute the precinct board member's oath of office.
- B. Before serving as a presiding judge of a precinct board, a person shall receive training in the duties of that position and be certified for the position by the county clerk.
- C. No person shall be qualified for appointment or service on a precinct board:
- (1) who is a candidate for any municipal, federal, state, district or county office;

- (2) who is a spouse, parent, child, brother or sister of any candidate to be voted for at the election;
or
- (3) who is a sheriff, deputy sheriff, marshal, deputy marshal, state or municipal policeman.

Absentee and Early Voting

The Village Clerk shall furnish an absentee ballot application. An application for an absentee ballot may be obtained by the voter from the Village Clerk in person, by telephone or by mail, and any voter may request an application for an absentee ballot for an immediate family member (“immediate family member” means spouse, children, parents, brothers and sisters.)

Requests for absentee ballot applications will begin on Tuesday, January 28, 2014. All applications for an absentee ballot must be completed and accepted by the Village Clerk prior to Friday, February 28, 2014, 5:00 p.m. After 5:00 p.m. on Friday, February 28, 2014, all unused absentee ballots will be publicly destroyed by the Village Clerk.

The Village Clerk will accept completed absentee ballots delivered from January 28, 2014 until 7:00 p.m. on Tuesday, March 4, 2014.

Between January 28, 2014 and February 28, 2014, absentee ballot applications and absentee ballots may be cast in person at the Village Clerk’s office at 7 Firehouse Road, Taos Ski Valley, New Mexico.

Between February 12, 2014 and February 28, 2014 early voting on paper ballots will be conducted at the Village Clerk’s office at 7 Firehouse Road, Taos Ski Valley, New Mexico.

Write-in Candidate Filing Day

No person can be elected as a write-in candidate unless certified as such by the Village Clerk. All write-in candidates must file in person at the Village Clerk's office on Tuesday, January 14, 2014 between 8:00 a.m. and 5:00 p.m. This is the only date and time on which a write-in candidate may file for office.

Write-in candidates shall file their declaration of write-in candidacy with the same documents and satisfy the same requirements as established for candidates.

If you cannot appear in person to declare your write-in candidacy, you may fill out an Affidavit Authorizing Filing of Declaration of Write-in Candidacy (form provided in this packet). This assigns a person to declare your write-in candidacy.

Last Day for Withdrawal of Write-in Candidacy

A declared write-in candidate may file an affidavit (form provided in this packet) that she or he is no longer a write-in candidate for Village office by January 28, 2014, at the Village Clerk's office, 7 Firehouse Road, Taos Ski Valley, New Mexico. In this event, any votes for such a candidate will not be counted and canvassed.

Please note that there are three Notaries Public in the Village office if you need their services.

Voter Registration

Persons desiring to register to vote in the VTSV election must register with the County Clerk of Taos County not later than Tuesday, February 4, 2014 at 5:00 p.m., the date on which the County Clerk will close the registration books. Registration forms are available at the VTSV offices, 7 Firehouse Road, Taos Ski Valley, New Mexico.

Absentee Applications Due

All applications for an absentee ballot must be completed and accepted by the Village Clerk prior to 5:00 p.m., Friday, February 28, 2014. After 5:00 p.m. on February 28, 2014 all unused absentee ballots will be publicly destroyed by the Village Clerk.

Voter Registration List Available

A voter registration list is available through the Village Clerk after February 12, 2014. There will be a charge for copies.

Last Day to Request Absentee Ballot Application

All application requests for absentee ballots must be received by 5:00 p.m. on Friday, February 28, 2014. Absentee ballots will be accepted until 7:00 p.m. on March 4, 2014.

Election Day

Be it resolved by the governing body of the Village of Taos Ski Valley that:

- A. A regular municipal election for the election of municipal officers shall be held on March 4, 2014. Polls will open at 7:00 a.m. and close at 7:00 p.m.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices:
 - 1. One Mayor for a four-year term
 - 2. One Councilor for a four-year term
 - 3. One Councilor for a four-year term
- C. The following location is designated as the polling place for the conduct of the regular municipal election:
 - 1. Voters registered in the Village of Taos Ski Valley shall vote at the Edelweiss Lodge and Spa Club Room at 106 Sutton Place, Taos Ski Valley, New Mexico.

Election Results

After 7:00 p.m. on March 4, 2014, the election judge proclaims and posts unofficial results of total votes cast for each candidate at the VTSV offices and at the Edelweiss Lodge and Spa Club Room polling place. Time will be determined by length of time it takes the precinct board to tally the ballots.

Any request for election information will be answered through the office of the Village Clerk.

Canvass of Election

By 12:00 noon on Friday, March 7, 2014 the Village Clerk must have begun a canvass of election returns; a canvass may begin any time after election returns, etc. are received from the precinct board; all canvassing must be done in the office of the Village clerk at which time the election results will be canvassed and declared.

Certificate of Election/Oath of Office

By Monday, March 10, 2014 at 5:00 p.m. at the VTSV office each elected officer will take the oath of office and sign a written statement acknowledging receipt of the certificate of election and that she or he is legally qualified to hold office.
